#### Introduction

- Nigeria has over 220 universities
- ❖Over 600, 000 graduates come out of universities yearly and less than 15% of this number get employed (NBS)
- Nigerian Universities are called upon to develop graduates that will not become a burden to the nation.
- This places a demand on universities to shift from a traditional teaching approach to an innovative teaching and learning method.
- The CCMAS came as a recognition to complaints from universities about the shortcomings of the curriculum.
- **GST** courses were streamlined. Consequently, venture creation, entrepreneurship and innovation were included.

#### Pedagogical strategy for teaching Entrepreneurship

#### Teaching vs Training

Teaching emphasizes understanding and conceptual comprehension. It focuses on imparting knowledge and facilitating learning.

Training places emphasis on application and execution. It concentrates on developing specific skills and abilities

#### ENTREPRENEURSHIP TRAINING

Research shows that entrepreneurship training is an effective means to promote entrepreneurship (Kim Bischoff et al., 2020).

Entrepreneurship training has positive effects on short and long term outcomes such as trainees' entrepreneurial intention, motivation, skills and entrepreneurial behavior (Martin, McNally, & Kay, 2013).

Entrepreneurship Training also attenuates the negative effect of capital constraints on business by developing financial mental models outcomes. In turn this also influences business creation (Frese, et al., 2020).

#### Approaches to Enterprise Education

#### **Action-oriented Approach**

#### This involves 3 learning channels:

- i. Learning through action
- ii. Learning through action principles
- iii.Learning through feedback (Bell & Kozlowski, 2002).

# ACADEMIC SERVICE LEARNING APPROACH (COLLABORATION WITH THE INDUSTRY)

ASL is modelled after the Igbo Apprenticeship System and hosted within the university (Ramson, 2014).

Under this system, there is a conscious effort from the GST unit to interact and partner with businesses for the purpose of knowledge and skill transfer.

#### Tracer Study Approach

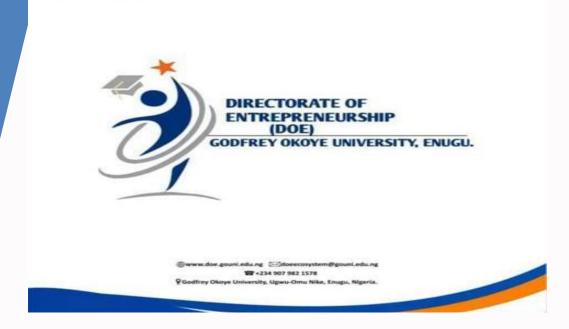
In a tracer study, data is collected and analysed repeatedly over time. For monitoring and evaluation purposes, tracer studies are often designed to track changes at individual level, following a development intervention.
